- Library in the school is changing the culture of reading with the students
- 132 grade 7's in the catchment which is steady number since 2009, and a percentage of these students will end up at Britannia, while others will leave the catchment
- Housing affordability is making it unaffordable for families in the area
- The Venture program for grade 8's has doubled in size and is one successful program bringing numbers up at Britannia Venture program is early version of International Baccalaureate (IB) program where typically students graduate ready for second year of many university programs
- Grade 8 has 30-45% of students reading at grade 4 level and numeracy skills behind grade level
- Despite these low levels, graduation rate is 92% of students showing that over 5 yrs in secondary the students are improving

• Partnerships at Britannia contribute to helping students by keeping them engaged, and providing more opportunities around the site

Britannia

- Cynthia looked into the funds being managed by the Vancouver Foundation. The endowment fund was established in 1995 with \$10,000 from the Board. Britannia gets annual interest of approx. \$1200-1600. Current value of the fund is \$50,100 (need actual total) due to contributions of individuals through the Foundation that are earmarked for Britannia. This money can't be used. The interest we accrue each year goes into our Discretionary Funds. To date \$40,372.08 interest received from Vancouver Foundation and \$496,108.86 in grants since 1999
- Cynthia provided a briefing note with information on nominations and appointments of Britannia Foundation members. Need a minimum of 5 members. 2 year terms up to 5 terms.
- Andrew will invite Tracy from the Metro Vancouver Alliance to attend the February Board meeting.
- Renewal Open House scheduled for January 17 has been postponed.
- Levi has agreed to work on phonetic pronunciation of šxwqwelewen ct Carving Centre for the public
- d) Seniors, Elders and Advocates (SEA)
 - The elders were able to raise \$8603.35 through their Silent Auction and craft sales for the Ashcroft Reserve that had been devastated by wild fires last year.
