3. Operational/Admin Reports

Recreation, Arts, Culture and Social Services

- 55+ is buzzing with activities; currently there are several programs that are running -Indigenous Drumming Circle, Weaving Our Community Together, Virtual Elder Sharing Circle, 55+ Zoom Hangouts, and Senior Elders and Advocate Meeting; there were 17 people participating in yesterday program
- The Hip Hop drop is going online this Friday June 12th from 7:00pm to 9:00pm; the event will be hosted by Dani and Lizzy with DJ Kookum through Zoom; this is for youth aged 12 to 18
- Sunday June 21st is Summer Solstice (the longest day of the year); It's also National Indigenous People Day, a day to recognize and celebrate the unique heritage, diverse cultures and outstanding contributions of First Nations, Inuit, and Metis people; Britannia is hosting a coffee house online through Zoom to celebrate National Indigenous People Day Summer Solstice
- Tom is working with Britannia Secondary School in preparing the graduation ceremony for 2020

Child Care

Britannia Child Care continues to be open for essential care workers and community • families who require extra support; there is still space for the 5 to 12 years old but not for the 3 to 5 years old or toddlers

Britannia

- Jackie is working with the supervisors to put together parent handbook and staff handbook about the procedure during COVID.; they are also looking at the reopening space and safety precautions
- Jackie is also looking at the Fall and the different phases and what that means to the child care. She is also reaching out to staff who were off to see who is willing to come back.
- VSB have approved for the additional space for Grandview Child Care

Administration and Accounting

- There is a small surplus of \$5,689 which is mostly due to Child Care grants; the OSC program received 7 times the normal funding from the BC Provincial Governments CCOF Grant for the month of April and May; the program also received its \$27,000 grant from the City of Vancouver this month; all the money is meant to be spent equally over the 12 months of the years
- Recreation running a deficit of \$45,136; this is primarily from Seconded Park Board wages and Maintenance Staff wages; Britannia will use a combination of federal government subsidies and its gaming grant to cover these deficits so that recreation can get back into a break even situation
- City of Vancouver have given Britannia the approval to run the Funseeker Summer Daycamp; Tom is working hard to put the program together
- Britannia have two staffs returning; Cyn (Communication Assistant) is back full time helping out with the COVID respond but she is working from home; Paul (FSC) is backing working only three days a week, Sunday, Monday and Tuesday.

Operations

• Cynthia is very appreciative of how hard the management team is working during COVID; everyone is very innovative, making sure everything is running smoothly

4. Partners' Reports

Megan Langley (VPL)

- The VPL is still in phrase one, moving into phase 2
- There are four branches getting ready to open to the public
- VPL is getting material out to people with vision impairment and home bound individuals.
- The computer lab is open at the main branch
- The library take out curve side pick-up service is still available; currently the libraries stop taking additional request because the demand is overwhelming;
- On June 18, there will be zoom story telling of indigenous people
- There are two community librarians working at downtown branch.
